Abstract:

The Save Sandy Beach Initiative Coalition/Ka Iwi Records collection contains documents related to organized community efforts to initially preserve Sandy Beach, which later expanded to preserving the whole Ka Iwi coastline; along with initiatives for downzoning the area from residential to preservation lands in the 1988 Hawai'i General Election, the Hawai'i State Supreme Court's 1989 override of election results, attempts to regain the public right to vote on land-use initiatives, and ultimately land purchases to ensure protection of the Ka Iwi coastline. The records included revolve around administration, correspondence, legal, newspaper clippings, organizations, and public relations.

The overall effort has employed multiple strategies and transformations in phases, which account for the numerous formations of different groups and organizations. Essentially there are four phases that reflect the chronological time movement of the community: *Save Queen's Beach Phase (1981-1986), Save Sandy Beach Phase (1986-1989), Restore Land-Use Initiative Phase (1989-1992), and Public Land Purchase Phase (1992-2002).*

Audio & visual media, and ephemera artifacts are grouped together by format.

Appended to this collection are elements that do not fit into the official series date ranges and are labelled *Out of Range*.

Agency History

Queen's Beach Phase (1981-1986)

The Save Sandy Beach Initiative Coalition has a very rich history with beginnings in 1981-1986 as the *Save Queen's Beach Association*, and its successor, *Friends of Queen's Beach*, to oppose development in the Queen's Beach section of O'ahu's East shore coastline from the Makapu'u Lighthouse access road to the Wawamalu Beach. The group consisted of a core of 6-12 people, but had a support network that was much bigger and numbered into the hundreds.

Save Sandy Beach Phase (1986-1989)

At the time The Sandy Beach Coastline encompassed Wawamalu Beach ("Alan Davis") rock wall to Koko Head, near the Halona Blowhole. The focus of this phase was to oppose housing development across the highway from the Sandy Beach Coastline from a development proposal in 1986. In 1987 the City and Council approved 2 permits to build houses. In response to the City Council approval, the grassroots organization birthed the *Save Sandy Beach Defense Fund*, and brought a lawsuit against the City Council. In addition, the *Save Sandy Beach Initiative Coalition* was created to draft an initiative ballot so the people of Hawai'i could vote to whether to downzone the area from residential to preservation and stop development.

For the election 66% majority voted statewide to downzone the area and halt development, however, this decision was overruled in 1989 by the Hawai'i Supreme Court, whereby the Court stripped voters of their land-use initiative voting rights. However the group continued to conduct other actions to halt development such as: various communications & planning with the community, voter registration drives, petition drives, mailings, public events, coordination with environmental groups, beach/highway cleanups, presentations to Neighborhood Boards, City Council testimony, public demonstrations, and sign waving.

Restore Land Use Initiative Phase (1989-1992)

The work done by the group during 1989-1992 is characterized as the *Restore Land-Use Initiative* phase. At that time, meetings were conducted for the purpose of restoring the initiative for land zoning decisions by the state legislature. Though the Hawai'i State Supreme Court invalidated the initiative in June of 1989, the group continued to advocate for restoration of the initiative through 1992. Attempts to restore the initiative were unsuccessful.

Public Land Purchase Phase (1992-2002)

From 1992 through 2002, the group entered into a *Public Land Purchase* phase. In 1998, under the Cayetano Administration, the State of Hawai'i successfully purchased Queen's Beach from Bishop Estate. In 2002, the City and County of Hawai'i was also successful in purchasing golf course parcels 5 and 6, the parcels were included in the 1988 Save Sandy Beach Initiative election.

Scope & Content Note

The Save Sandy Beach Initiative Coalition/Ka Iwi Records Collection, is split into six series chronicling efforts to oppose housing development along the Ka Iwi coastline, between 1981 - 2002:

Series 1: Save Queen's Beach (1981-1986) Series 2: Save Sandy Beach (1986-1989) Series 3: Restore Land Use Initiative (1989-1992) Series 4: Public Land Purchase Phase (1992-2002) Series 5: Audio-Visual Series 6: Ephemera

The contents of Series 1, *Save Queen's Beach (1981 - 1986)*, which began as two grassroots groups, contains administrative records, correspondence, legal documents, newspaper clippings, information about organizations, and public relations materials.

Series 2, *Save Sandy Beach (1986-1989)*, continued the efforts of the *Save Queen's Beach* campaign, opposing housing development across the highway from Sandy Beach coastline. The records within pertain to the initiative opposing housing development and getting the initiative on the ballot to downzone the area from residential to preservation land in the Hawai'i State General Election of 1988. Citizens throughout the state were allowed to vote on land use initiatives, with a majority in support of downzoning, which was later overturned by the Hawai'i Supreme Court, in 1989; ending Series 2. This series contains administrative records, correspondence, legal documents, newspaper clippings, information about organizations, and public relations materials.

Series 3, *Restore Land Use Initiative (1989-1992)*, documents the phase in which the coalition worked to persuade the state Legislature to amend state law, following the Supreme Court ruling. The initiative attempted to restore land-use voting rights to the public. Documents include: meetings, Initiative efforts, Hawai'i Supreme Court's written opinion invalidating the Initiative's election results, ending with ongoing attempts to get the State Legislature to restore the initiative for land use decisions.

Series 4, The *Public Land Purchase Phase (1992-2002)*, follows the organization's efforts to purchase the land for conservation, the State's purchase of Queen's Beach from Bishop Estate, and the City and County of Honolulu's purchases of land parcels.

Series 5, *Audio-Visual*, contains audio and video format materials corresponding to the efforts of the initiative.

Series 6, *Ephemera*, contains memorabilia in the form of t-shirts, a banner, and a framed Earth Day Hawai'i '95, Mālama 'Āina Award.

Appended to this collection are elements that do not fit into the official series date ranges and are labelled *Out of Range*.

Description of Contents:

The Save Queen's Beach (1981-1986) series, chronicles the beginnings of the Initiative to oppose development of Queen's Beach, which was defined as the section of the coastline from Makapu'u lighthouse access road toward Koko Head to the Wawamalu Beach "Alan Davis" rock wall. Efforts to preserve Queen's Beach were undertaken by two grassroots groups: The Save Queen's Beach Association (associated names Ed Arrigoni and Bob Britts), and its successor, Friends of Oueen's Beach (associated names Shirley Lum, Phil Estermann). This series contains records that were used by the organizations during their active period of operations, and is comprised of the following categories: Administrative, which is further broken down into sections: General, Constitution, Minutes, Resolution, Roster and Membership. Correspondence holds all correspondence arranged chronologically and divided into a Part 1, and Part 2. Legal, contains all legal documents and is further broken down into the following: Testimony to Honolulu City Council, Petitions, Permits, Resolutions, Standard of Conduct, Department of Parks and Recreation, Department of General Planning, and Research Material. Newspaper *clippings*, is divided into the following: Articles Related to Tourism Industry, Undated News Clippings, Newspaper Clippings 1981-1984, Newspaper and Magazine Opinion Articles (Editorials). Organizations, holds information about external organizations, and is further broken down into the following: Kaiser Development, Wawamalu Association, Nature Conservancy of Hawai'i, Sierra Club, and the Hawai'i League of Conservative Voters. Public Relations, holds records and publications related to public outreach and awareness, as well as marketing campaigns for fundraising, and is split into the following: Marketing, Publications, Speeches, Surveys, and Press Releases.

Description of Contents:

The Save Sandy Beach (1986 - 1989) series, expands the reach of the Queen's Beach Initiative, to include the section of the coastline from the Wawamalu Beach "Alan Davis" rock wall, towards Koko Head, near the Halona Blowhole. Efforts continued in opposition of housing development across the highway from the coastline. This series explores the details which led up to the 1988 election, in which the entire state of Hawai'i was allowed to vote upon the initiative opposing housing development along the coastline. The election results, which received a 66% majority vote statewide to downzone the area from residential to preservation land, and which would halt development, were overruled in 1989 by the Hawai'i Supreme Court, whereby the Court stripped voters of their land-use initiative voting rights. A few weeks after the ruling, in June of 1989, bowing to public sentiment, the Honolulu City Council downzoned all properties covered within the election initiative. While this was a win for preservation of the land, the public lost its right to vote on land-use initiatives. Included are details on meetings, communications and planning, the filed lawsuit, voter registration drives, petition drives, mailings, coordination with environmental groups, beach/highway cleanups, presentations to Neighborhood Boards, City Council testimony, and public demonstrations. The series is divided into 6 categories. Administrative, holds information about meetings, resolutions, membership and committee lists, fiscal records, a chronology, and a coalition information package. Correspondence contains all correspondence during this time. Legal, contains bills, testimonies and hearings, court cases, petitions, permits, elections, and research material. Newspaper clippings, contains various clippings during this time period. Organizations, contains information about external organizations, Public Relations, contains records of campaigns/initiatives, fundraising, marketing, publications, speeches, and surveys.

Description of Contents:

Contents of the *Restore Land Use Initiative (1989 - 1992)* series, include administrative documents used for meetings, public outreach planning, and the 1989 *Restore Initiative*, which began in May. In June of 1989, the Hawai'i State Supreme Court had issued a written opinion that invalidated the results of the 1988 election. These records from 1989 - 1992 document efforts by the group to get the State Legislature to restore the initiative for land use decisions back to the people of Hawai'i. These efforts were ultimately unsuccessful.

Contents are divided into sections: *Administrative*, which contains meeting minutes; *Legal*, which contains testimonies, court cases, and research materials; *Newspaper clippings* that were collected during this time period, and *Public Relations*, which contains publications by the group.
